





Capital Affordable Housing Funding Corporation

Housing Counseling Program

The AHP Homeownership Center's counseling program assists first time buyers and homeowners facing foreclosure with advisement and connection to resources. The Partnership met with 446 new customers this year, 10 fewer than last year. AHP offers its services to any household in the Capital District, with a special focus on residents in the City of Albany.

Customer Residence






Pre-Purchase Programs

COVID-19 had little impact on AHP's pre-purchase program. First time buyers continue to seek out information about mortgage and down-payment assistance programs. Attendance at HomeBuyer 101, the Partnership's orientation class, remains strong, in spite of the shift to an online webinar format. This year we provided information to **723** households, 4% fewer than last year. Since 2010, 6,716 households have attended the class.

After attending Home Buyer 101, customers are referred to AHP's Money Strategies class, or if credit scores are strong enough, to an individual counseling session.

In 2020, **123** households (+6% over last year) attended AHP's Money Strategies course to learn how to strengthen their credit score. The online class incorporates Q&A and polling opportunities to engage participants.

On par with last year, **354** households met one-on-one with our pre-purchase advisors in preparation of buying a home. Meetings were by phone or Zoom.




When customers are ready to start looking for a home, they are referred to AHP's comprehensive homebuyer education workshop. **198** households completed the program this year, 154 of whom completed an online class. In person classes ended in January 2020.

AHP's counseling program meets HUD requirements and national industry standards. AHP is a HUD certified housing counseling agency and has four HUD certified housing counselors on staff.

In 2020, AHP assisted 198 households (-4% from prior year) purchase their first home for a real estate investment of over \$34 million.

Income

•78% of homebuyers in 2020 earned less than 80% of area median income

- •68 buyers bought homes in the City of Albany (35% of all buyers)
- •The most popular communities to purchase in were Albany's Delaware Avenue and Western Avenue neighborhoods and the town of Colonie

- •At least 40% of buyers used down payment assistance programs

Landlord Training: In collaboration with United Tenants of Albany and the Albany Housing Authority, AHP offers Landlord Training classes to help small property owners become successful landlords. In 2020, AHP facilitated 3 workshops attended by current and potential rental property owners.

Credit Consultations: In addressing a strategic goal set by AHP's board of directors, AHP's long-time housing advisor Tracy Petersen created a program to assist households with more indepth credit repair counseling. Tracy works with the household to create a sustainable budget that addresses old credit issues that prevent mortgage approval.

Foreclosure Prevention Counseling

COVID-19 had a major impact on the demand for mortgage delinquency counseling. Last year, nearly 1,300 Capital Region households a month received notices of intent to foreclose from their lender. During Fall 2020, notices of intent dropped to just over 400 per month. Many mortgages are still in forbearance, and lenders have not yet required repayment.

Once courts reopen and forbearances end, AHP anticipates a large demand for services. AHP has received funding from the City of Albany and Town of Colonie to provide assistance toward payment of arrears. The City of Albany has also provided funding for program marketing.

During the year, 78 households were counseled. Default counseling helps families understand their options and negotiate with their lenders when feasible to resolve mortgage delinquency and prevent foreclosure.

- The primary cause of mortgage delinquency remains loss of income, followed by increase in medical expenses
- The top foreclosing entities are Wells Fargo, PHH and Carrington.
- Twenty-nine percent (29%) of clients were City of Albany residents; an additional 20% were Albany county residents outside the City, followed by Saratoga County residents (15% of clients).

HomeSave Coalition is an effective coalition of housing counseling agencies and legal services:

- Monthly HomeSave Coalition meetings facilitated by AHP
- Counselors and legal service providers stay current with program initiatives and troubleshoot issues.
- Continuing education for counselors and attorneys
- Data analysis of foreclosure data from the Department of Financial Services.
- Monthly mailings to delinquent households about availability of services.
- Maintained HomeSave.info website.



Energy Efficiency Outreach Program

AHP partners with NYSERDA in the implementation of the Community Energy Engagement Program to inform Capital Region residents of the availability the Home Performance with Energy Star energy retrofit program through NYSERDA. This program features home energy assessments coupled with financial incentives to complete recommended energy saving improvements. This year, AHP energy staff assisted 237 new households take the first steps toward a more energy efficient home.



Program Highlights:

- AHP remains a top ranked NYSERDA program partner in New York State.
- AHP has been a key partner in the region's GHHI Initiative. This year has been focused on developing a business plan to fund home interventions (home visits by asthma educators and home repairs) to reduce asthma attacks caused by poor housing conditions.
- AHP is using home repair funds from NYS's Affordable Housing Corporation to match NSYERDA funds to complete projects or to complete improvements that prevent energy projects from proceeding (roof repairs, mold remediation, etc.)

Capital Affordable Mortgage Program

The Capital Affordable mortgage portfolio now includes 55 loans with an outstanding balance of \$719,764 (down nearly 26% from last year). Loan balances are fairly small – at 11/15/20, the largest performing loan in the portfolio had a balance of \$29,080. The delinquency rate is 4% (2 loans), with one loan in foreclosure.



Community Realty


Community Realty is a social-purpose real estate brokerage launched by the Homeownership Collaborative.





property manager, manages 56 residential rental units for the Albany Community Land Trust and 12 commercial units located at the Albany Center for Economic Success at 255 Orange St., Albany. As needed, Community Realty also manages Capital Affordable owned real estate, including property management and marketing.





The Partnership continued its strong working relationship with the Albany Community Land Trust and its two programs: acquisition, rehab and management of affordable rental housing and acquisition, rehab and sale of homes to first time buyers. The Partnership and Land Trust share administrative staff.

The Land Trust manages 56 affordable rental units with the expert help of Dan Torres and Lisa Petruzzelli. During the year, ACLT completed the substantial rehabilitation of 9 rental units, with 5 more under construction

with funding secured from NYS Homes and Community Renewal and Enterprise Community Partners. ACLT has plans for the rehab and sale of two existing homes and advanced a partnership with Habitat for Humanity Capital District for the new construction of 6 homes for owner occupancy.

Community Development Alliance

The alliance between the Partnership, Albany Community Land Trust, Community Loan Fund of the Capital Region and United Tenants continued work on its collaborative projects, including shared staffing.



<u>Sheridan Hollow Opportunity Area</u>: Planning work for the redevelopment of Sheridan Hollow has been finalized thanks to funding from the Department of State's Brownfield Opportunity Areas program. AHP worked with expert consultants to complete projects such as a Complete Streets plan, designs for the Memorial Park at Sheridan and Dove, and policy development work such as an emergency demolition white paper. The Alliance provides oversight of the planning initiative.

A key initiative of the plan is to increase resiliency in the neighborhood. During the year, AHP facilitated the installation of rooftop solar arrays on 8 homes owned by low income households, using funding from NYSERDA's Cleaner Greener Communities initiative.

The Alliance was also successful with a funding application to the Attorney General's Mission Based Affordable Housing initiative. Alliance members have partnered in providing technical assistance to congregations interested in affordable housing development.


